Ethical Guidelines - MMSA

1. The responsibility of members for the welfare, health and safety of the community shall at all times come before their responsibility to the profession, to sectional or private interests, or to other members.

2. Members shall act so as to uphold and enhance the honor integrity and dignity of the profession.

3. Members shall perform work only in their areas of competence.

4. Members shall build their professional reputation on merit and shall not compete unfairly.



Ethical Guidelines - MMSA

5. Members shall apply their skill and knowledge in the interest of their employer or client for whom they shall act, in professional matters, as faithful agents or trustees.

6. Members shall only give evidence, express opinions or make statements in an objective and truthful manner and on the basis of adequate knowledge.

7. Members shall continue their professional developments throughout their careers and shall actively assist and encourage their fellows and those under their direction to advance their knowledge and experience.

8. Members shall comply with all laws and government regulations relating to the mineral industries.



MMSA Ethical Guidelines Interpretation Clause 4(b): bribe or facilitating payment?

In many countries, payments of varying size are commonly paid to officials in order to obtain permits, clearance for equipment and supplies, and a variety of other purposes. Such payments are known as "grease," "baksheesh," "facilitating payments," "bribes," etc.

Is it ethical to make such payments? If so, when?

How should the making of such payments be disclosed?

The FCPA* has no minimum % payment

- A \$1 million premier bribe to protect \$100 million in product exports from a country is enough. The loss of the \$100 million in product may be significantly material financially even though \$1 million is not.
- Bribes or social licensing costs?
 - Disclosure of the sums involved is the big difference.

Description for DOJ and SEC Enforcement Actions per Year

This chart identifies the number of Enforcement Actions the SEC or DOJ initiated per year, for each year since the statute's enactment. By hovering over a year, users can see the number of Enforcement Actions filed by the SEC and DOJ jointly file an Enforcement Action, that action is counted once for the SEC and once for the DOJ. See About Us - Datasets for a definition of "Enforcement Action." There are many ways to define an FCPA enforcement action and to count the number of such actions filed per year. This graphic presents one possibility among several.
